- 1 I have been provided with copies of and will be bound by and observe the terms of my NF's Nomination and Selection Criteria.
- 2 The NF Nomination and Selection Criteria may be amended by the NF from time to time. I will be bound by and observe the Nomination and Selection Criteria as amended, and acknowledge that any amendments to the Nomination and Selection Criteria will be posted to the AOC's web site ([www.olympics.com.au](http://www.olympics.com.au)) along with the Qualification system applicable to my event.
- 3 The decision whether or not to nominate me to the AOC for selection in the 2010 Australian Youth Olympic Team is subject to the Nomination and Selection Criteria and is at the discretion of my NF.
- 4 If my NF decides to nominate me for selection to the 2010 Australian Youth Olympic Team I will be required to sign a Team Agreement as determined by the AOC.
- 5 In the event that my NF nominates me to the AOC for selection in the 2010 Australian Youth Olympic Team I am not guaranteed to be selected in the 2010 Australian Youth Olympic Team. The decision whether or not to select me as a member of the 2010 Australian Youth Olympic Team is subject to the NF Nomination and Selection Criteria and IOC Quota Restrictions and is at the sole and absolute discretion of the AOC.

- 7 I will notify my NF in writing of any change in the above contact details. Any failure by me to advise my NF in writing of a change in my contact details may be to my detriment. Any announcement to be made or notice required to be sent may be sent to one or more of the above contacts, or such other contact as notified in writing by me, and in the case of:
  - (1) post, the announcement or notice is deemed to have been received by me by properly addressing, prepaying and posting a letter containing the announcement or notice, and to have been received on the third business day after the date of its posting. Any announcement or notice sent by post to me overseas will be forwarded by air mail;

- (2) email, the announcement or notice is deemed to have been received by me by properly addressing the email address and transmitting it to the address supplied by me and to have been received by me on the next business day after the date of transmission unless the AOC or NF is advised that the transmission failed to send to the addressee;
  - (3) team intranet, the announcement or notice is deemed to have been received by me by properly posting the announcement or notice to the team intranet, and to have been received on the third day of its posting.
- 8 The AOC may release your name and contact details to the media who may or may not contact you for editorial purposes. (Please advise the AOC if you do not want your name and/or contact details released to the media.)
- 9 The AOC may collect biographical information for use in any media or forum, including the internet. Biographical information will be collected through the AOC's on-line systems (team intranet). Usernames and passwords will be provided by the AOC to athletes to allow access to the on-line systems. The AOC Privacy Policy is available on olympics.com.au.
- 10 The AOC may collect personal information from me or about me from third parties including the IOC, WADA, ASADA, the Australian Institute of Sport, my State Institute or Academy of Sport, my NF, coach, manager, agent, guardian, consultant or advisor. This may include personal, health, medical or biological information. The AOC will only utilize this information in order to facilitate participation in the 2010 Youth Olympic Games and in accordance with the AOC Privacy Policy, available at olympics.com.au.
- 11 I have not and will not at any time engage in conduct (whether publicly known or not and whether before or after the date of my selection, if I am selected), which could bring or would have the tendency to bring me or my sport into disrepute or censure, or which could be or would have the tendency to be inconsistent with, contrary to or prejudicial to the best interests, image or values of the AOC or Team Sponsors, or as a result of which my continued membership would not be or would not be likely to be in the best interests of the Australian Youth Olympic Team.
